• Everleigh HRC – Consultation 3<sup>rd</sup> September and met with Jane Scott to look after rural communities.

Cllr Stock stated she had looked at the usage graph which was non-sensical.

- Electoral Review Now expect number of Councillors to be announced late August.
   Thereafter review of boundaries.
- Special Needs Schools Consultation runs to end July.
  - 'In May 2018 Wiltshire Councillors agreed to consult on proposals to increase the special school provision for children and young people with complex needs and severe learning disabilities in the north of the county.
  - o There will be other consultations and discussions at a later date about:
    - School places in the south
    - School places for children and young people with autistic spectrum disorder (ASD) and social emotional and mental health (SEMH) and also
    - Resource base and enhanced learning places in mainstream schools.
    - This process is not about closing special schools. Wiltshire plans to increase, not take away school places.
  - For this consultation, there are three proposals we would like your views on how we can:
    - Create new special school places for children/young people with complex needs<sup>1</sup> in the north of the county
    - Develop good schools which help children and young people to learn and be confident for now and the future
    - Shape the best education and support which will keep and attract high quality teachers and professionals
    - Manage all this within the funding that can be made available
    - Involve everyone in making good decisions'
- Outdoor Centres Delayed closure to end Dec to allow for proper bids only considering bids that enable continuing outdoor activity provision. Closure delayed until December to allow encouraging bids.

Cllr Stock asked if they were closed what would happen to the properties.

Cllr BP stated it would depend on the area as Oxenwood would not be appropriate area for new development in line with planning policies.

- Preliminary Planning Consent See Briefing Paper 349.
  - 1-9 houses as Government imposed directive to develop in a short time frame.

Cllr Geraghty asked what defined a small hamlet.

Cllr BP stated the policy is to discourage development in small villages rather than towns.

• Portfolio Holder for ICT and Digitisation – Just let £6M contract with Microsoft to take forward our digitisation strategy over next 2 years and bring a significant change.

- Parish Chairmen Meeting. Greater 'information/contact sharing' and potential for collaboration. Next meeting to inc boundary factors. He stated that he was surprised how little the chairman knew of each other.
- Mink Farm incident. The deputy chairman of Netheravon was called out by a lady who
  overlooked the old mink farm. A large truck arrived with a large skip and was trying to get in
  and drove across the field apparently intent on fly tipping. When they realised they were
  being filmed they scarpered and were picked up on the A303 by the police. Follow up
- SPTA fires and smoke. Council Leader spoken to Comd SW Nuisance to local villages
- Helium Balloons and Lanterns Council agreed to ban on Council property as an issue to farmers and animals.
- Lower House Farm Stables Planning Application.
   Cllr Blair-Pilling stated that the planning officer would more than likely approve the application.

The Clerk advised that she had spoken to the planning officer who confirmed he was waiting for the report from the Conservation Officer. The officer was concerned that any new owners of Lower House Farm would then want to build outbuildings.

Cllr Stock stated that the Conservation officer should protect the area

Cllr BP stated he has met with the applicant and architect and proposed they reduce the number of houses of which the applicant refused.

The Clerk asked if this was normal practice to be personally involved.

Cllr Blair-Pilling advised that he was trying to be helpful and that it would be called into the Area Planning Committee on either August 9<sup>th</sup> or September 6<sup>th</sup> at 3pm at Devizes Town Hall.
